Es ist oxidationsstabil, nicht schäumend und besitzt ein ausgezeichnetes Viskositäts-Temperaturverhalten. Aufgrund des niedrigen Stockpunktes lässt sich dieses Öl bei tiefen wie bei hohen Temperaturen verwenden und garantiert eine einwandfreie Schmierung. Es ist geeignet für den Einsatz in den meisten mit Benzin und Diesel betriebenen Fahrzeugmotoren / klassischen Fahrzeugen vor Baujahr 1979. SECTION 4: First aid measures

4.1. Description of first aid measures

General information:
